

# **Volunteer Terms & Conditions**

## **European Juggling Convention 2026**

August 1-9, Ptuj, Slovenia

### **1. Definitions**

- 1.1. Volunteer Terms & Conditions: This document in its entirety. Festival: The
- 1.2. European Juggling Convention 2026.
- 1.3. EJC: The organizing team of the European Juggling Convention 2026.
- 1.4. Volunteer: Any person providing unpaid support to the festival under these Volunteer Terms & Conditions.
- 1.5. Coordinator: A designated representative of the EJC responsible for volunteer management.
- 1.6. Festival Site: All designated areas and times in which the festival and its related activities take place.

### **2. General Clauses**

- 2.1. These Volunteer Terms & Conditions apply to all volunteers
- 2.2. Volunteers acknowledge that their engagement is voluntary and does not constitute an employment relationship. Volunteers are required to follow instructions and
- 2.3. policies provided by the EJC, coordinators, and authorities.
- 2.4. Volunteers must respect the festival's house rules and codes of conduct at all times.
- 2.5. The EJC may modify these Volunteer Terms & Conditions at any time and will announce any changes.



### 3. **Responsibilities**

- 3.1. Volunteers are expected to carry out assigned tasks responsibly and in good faith.
- 3.2. Volunteers must be punctual and inform the coordinator of any delays or absences.
- 3.3. Alcohol and drug use is not allowed while performing volunteer tasks whenever the coordinator specifies that sobriety is required for safety or effective execution.
- 3.4. Volunteers must immediately report unsafe situations, accidents, or incidents to a coordinator.

### 4. **Conduct**

- 4.1. All volunteers are required to adhere to the [EJA Safeguarding Policy](#), which outlines expectations regarding respectful behavior, safety, inclusion, and boundaries.

### 5. **Liability and Insurance**

- 5.1. The EJC maintains liability insurance covering volunteers for damages or injuries that occur during volunteer work.
- 5.2. Volunteers participate at their own risk. The EJC is not liable for personal belongings lost, stolen, or damaged during the festival.
- 5.3. Volunteers agree to handle all festival property and equipment with care and to report any damage immediately.



## 6. **Accommodation and Meals**

- 6.1. If applicable, volunteers may be offered a camping spot on the festival campsite under the same rules as visitors.
- 6.2. Meals or meal vouchers may be provided during volunteer shifts as determined by the EJC.

## 7. **Photography and Media**

- 7.1. Volunteers consent to the EJC using photographs and video footage of them taken during the festival for promotional purposes.
- 7.2. Volunteers who object to image use must notify the EJC in writing prior to the start of the festival.

## 8. **Final Clauses**

- 8.1. These Volunteer Terms & Conditions are governed by Slovenian law.
- 8.2. Disputes related to these terms shall be exclusively settled by the competent Slovenian court.
- 8.3. Should any provision of these Volunteer Terms & Conditions be deemed invalid, the remaining provisions remain in full force and effect.
